CONGREGATION COUNCIL - PRESIDENT'S REPORT

Greetings, let's review some highlights from 2022:

We completed 54+ in-house and virtual church services throughout 2022. We completed 'Ashes to Go' on Ash Wednesday with Holy Week services. On Easter we held 2 services. We've had consistent Midweek prayer virtual services since May 2020. We hosted the Memorial Day service at our cemetery. We completed a confirmation service, new member services, weddings, funerals, first communion, baptisms, Thanksgiving Eve, Christmas Eve services x2, Christmas Day and New Year's Day services. Together, we celebrated new lives and mourned the loss of many family members and friends that have gone on to heaven before us.

The Cinnamon Bun Bake Sale returned in April. We hosted our first post pandemic coffee hour on June 5th. We assisted with organizing and completing Joint (UCC) outdoor services.

We hosted and served 6 Community Free Dinners: 1/21 (chili), 3/18 (pot pie), 5/21 (meatball sandwiches), 7/15 (sausage sandwiches), 9/16 (ham dinner) and 11/11 (turkey BBQ).

We hosted the Halloween Hot Dog and treat stand. Craft Night returned and was a blast. St. Nick visited our annual Christmas Party, and we co-hosted the Community Christmas Tree Lighting. The Basket Social and Bake Sale continue. Boscov's Day! The Thanksgiving sides!

We tithed 10% to 'in-need families' from church funding events. 5% of our 2021 Endowment Fund interest was donated to the Fogelsville Fire Co. We donate regularly to the Food Banks at Christ Church at Lowhill, Parkland CARES, Second Harvest and St. Paul's. We have given almost 200 lbs of food to St. Paul's Food Pantry and Parkland CARES. At our annual Christmas Ingathering and Angel Tree we donated items and money to the Rescue Mission, Turning Point, Good Shepherd in Bethlehem, the Topton Home. In addition, we donate to the Northeast PA Synod, Lutheran Congregational Services, Lehigh County Conference of Churches, and Our Daily Bread Ministries.

We remain strong as a church family and have continued to carry on God's mission in the community. We gather weekly and pray and sing together. We are blessed with many traditions and life gifts, the ability to share our gifts, and spread the Gospel. We invite you to make it your New Year's resolution and come to church weekly. Join in on as many events as you can. We need your continued presence, support, help and prayers in 2023.

I've had a great 3 years being your Council President and want to thank you all for your support and prayers throughout my tenure. Best wishes to Mike Divers as he moves into the Council President's role.

Congregational Meeting Minutes – November 13, 2022 (following worship)

The meeting was called to order by Vice President, Mike Divers.

Budget Highlights:

- Budget increase was largely due to increase in oil price
- Lowering temperature in sanctuary to decrease oil use
- Discussion concerning benevolence- what comes in designated on envelopes goes out
- Our church has many other ways to give to the community such as 10% of all fund raisers, community free dinners, hot dog stand, ingathering, etc.

• Lisa Herman brought up the need to transfer \$25,000 from the Laudenslager and Sheppard funds so far this year. At this rate they will be gone in the near future. She brought up Web bill pay from your bank. Funds are taken automatically from your account and a check is sent to the church at no cost to you. This would allow your contribution to be sent if you were there in person or not.

A motion was made by Diane Heintzelman, seconded by Ken Divers, to adopt the 2023 budget. The motion passed.

Addendum- November 20:

Mike Divers continued the meeting with nominations for Church Council. Matthew Kressin and Brad Sell were nominated by Beth Kressin and Curtis White, seconded by Stacey Divers. The motion carried and both were added to the Church Council.

SEXUAL OFFENDER POLICY

St. John's is committed to being a religious community open to those who are in need of worshipping with us, especially in times of distress and serious personal troubles.

The safety of our children (all ages) and adults who attend St. John's is our first priority. This policy will help ensure that everyone attending our church will feel safe when or if a sexual offender is worshipping with us. Secrecy about certain situations with the church may encourage abuse while transparency makes everyone safer. The identity of any person convicted of being a sexual offender will not be kept secret.

Our policy will include such items as: Background checks (who needs to have them), procedures to be in place when sexual offenders are attending services (what they can or cannot participate in, how often can they attend, how they must report in and who will be their escort)

BACKGROUND CHECKS: (background checks must be completed by the following 18 years of age and older but not limited to):

- All paid employees
- Sunday School teachers and helpers
- Vacation Bible School teachers and helpers
- Youth Group volunteers
- Miscellaneous activity volunteers such as egg hunt, Christmas party, Community Free Dinner, Christmas craft night, etc. (any activity where youth under the age of 18 will be attending/helping)

St. John's Lutheran Church has decided that it will allow sexual offenders to only attend worship services with certain restrictions:

- First, the offender's Probation/Parole Officer needs to be contacted to see if there are any restrictions regarding attending services.
- If a victim of the sexual offender attends church services at our church, is a member of the congregation, or is an employee of the congregation, the sexual offender shall not be permitted to attend worship services at St. John's.
- The offender must review our Limited Access Agreement. Sign the agreement that they have read our policy and will abide by it. If the offender refuses to sign our Limited Access Agreement, the offender will not be permitted to attend worship services.

If above restrictions do not prohibit offender participation, the following additional requirements will be implemented and will remain in force in perpetuity:

- The Congregation needs to be made aware that a convicted offender may be attending worship.
- The convicted offender cannot participate in any child or youth program(s).
- The convicted offender can only attend one predetermined service each week and must contact the escort team lead no later than Wednesday before the Sunday they want to attend.
- The convicted offender must report to their assigned escort and will always be accompanied while on church property.

St. John's will develop an escort team {also known as Team} with the current Council President being appointed as Team Lead and several Council members and or congregational members. They will volunteer to be escorts {also known attendant} as needed. The Team Lead will assign an attendant to be with the offender while worshipping on the date the offender requested. The attendant assigned cannot be related in any fashion to the offender. Attendant training will be determined by Council. St. John's attendant expectations include:

- The offender is never to be left alone.
- The offender should be escorted to the restroom as needed (suggested the bathroom by the sanctuary to be used).
- The attendant is always to arrive before the offender.
- The attendant should sit in the pew behind the offender.
- If attendant cannot attend, they must contact the team lead before the service (if a replacement attendant cannot be assigned, the offender cannot attend worship)
- When offender arrives, they should be greeted with dignity and respect.

The Pastor and President of Council will periodically meet personally with the offender to make sure that they are being treated with dignity and respect while attending worship and to discuss matters of mutual interest and concern. These meetings will also serve as an ongoing review of the offender's compliance with our Limited Access Agreement.



STEWARDSHIP – COMMUNITY FREE DINNERS

Community Free Dinner Coordinators Dave Neimeyer and Bob Neumoyer along with St. John sponsors and volunteers continued to host the 2022 Community Free Dinner program here at St. John's. The dinners were offered on the third Friday of January, March, May, July, and September, with the final dinner for 2023 in November being offered on the second Friday of the month! All dinners were held as drive-through take out meals. Thank you to Fogelsville Fire Police volunteer Jeff Eisenhard for safely assisting guest vehicles into our parking lot for food pick-up. We will continue to serve our guests from 5:00 – 7:00 PM or until all dinners have been distributed.

The January dinner was held on Friday, Jan 21st and sponsored by Dave Neimeyer. We handed out about 130 drive-through meals, each receiving take-out bags containing a pint containers of home-made chili, fresh dinner rolls, carrots and celery sticks, bags of chips, applesauce, and a brownie. Most helpers took home some meals for themselves or neighbors. By Sunday morning only a handful of meals were left in the refrigerator for parishioners at our 10:30 Am service.

Our Second Community Free Dinner was sponsored and hosted by the St. John's Ladies Aid on Friday March 18th. The table fare included Chicken Pot Pie, Cole Slaw, apple sauce, roll and dessert. We served 150 guests.

In May, the dinner was sponsored by the St. John's Adult Sunday School Class. We served 196 dinners of meat balls, a sub roll from Sam's bakery, macaroni salad, chips, and lemon squares to our visitors and volunteers. May dinner guests donated \$193.00 that was returned to our Community Free Dinner fund for future dinners. Thank you to Christine Snyder for expediting the supply donations from U-Line. These supplies will serve our dinners for months to come!

St. John's Church Council sponsored our July take-out dinner. The meal included sausage sandwiches, steak roll, chips, applesauce and dessert, served until 6:00 PM when all food given out. We served 182 guests. After expenses \$217.00 from guest donations was given back to the church and the Community Free Dinner fund.

September's dinner was hosted by Becky & Bob Neumoyer. 93 large ham slices were purchased from Thompsons Meat market. Since these slicers were huge, we cut them in half for this dinner. The remaining slices were packed and frozen to be used in the beginning of 2023 for a future ham & string bean Community Free Dinner. We started the evening delivery early as cars started to line up at 4:00 PM. By 5:00 PM we had already given out over 40 dinners! Clean-up started a little after 6:00 PM. Another successful dinner, having served 183 guests. We received \$185.00 from visitor donations that was donated back to our Community Free Dinner fund.

Our November Turkey BBQ take-out dinner was sponsored by Sharon and Bob Snyder.
